THE SCHOOLS' COUNSELORS REFER FAMILIES WHO HAVE THE GREATEST NEED AMONG THE MANY CHILDREN AT RISK. ALL RECIPIENTS FALL BELOW THE NATIONAL POVERTY LEVEL AND/OR ARE HOMELESS. EACH REFERRED CHILD, FROM KINDERGARTEN THROUGH 5TH GRADE, RECEIVES A WINTER JACKET, TWO PAIRS OF PANTS, TWO TOPS, FIVE PAIRS OF UNDERWEAR, SIX PAIRS OF SOCKS, A DENTAL KIT, AND AN AGE-APPROPRIATE BOOK.
